□ Your personal data have been unlawfully processed

 $\Box$  Your personal data have to be erased for compliance with a legal obligation which exists on the part of Luceda

□ Your personal data have been collected in relation to the offer of information society services

### □ Right to restriction of processing\*

You wish Luceda to limit the processing of your personal data and one of the following grounds applies:

□ You contest the accuracy of your personal data. Your personal data will not be processed for the period enabling Luceda to verify the accuracy

□ The processing is unlawful and you oppose the erasure of your personal data and request a restriction of the use of your personal data instead

□ Luceda no longer needs your personal data for the purposes of the processing but you require them for the establishment, exercise or defence of legal claims

□ You have objected to processing your personal data and pending the verification whether the legitimate grounds of Luceda override yours, Luceda will not process your personal data

# □ Right to portability of your personal data\*

 $\Box$  You wish to receive the personal data – which you provided to Luceda – in a structured, commonly used and machine-readable format

□ You wish that Luceda transfers your personal data to another controller for processing and one of the following grounds applies:

□ The processing is based on your consent

□ The processing is carried out by automated means

Note: The transfer by Luceda will only take place when it is technically possible for Luceda to do so

# □ Right to object\*

□ The processing of your personal data (including profiling) occurs (i) for the performance of a task carried out in the public interest (ii) in the exercise of official authority vested in Luceda or (iii) on grounds of the legitimate interests of Luceda or a third party and you wish to object to the processing of your personal data on grounds relating to your particular situation.

<u>Note</u>: Luceda shall no longer process your personal data unless Luceda demonstrates compelling legitimate grounds for the processing which override your interests, rights and freedoms or for the establishment, exercise or defence of legal claims

□ You wish to object to the processing of your personal data for direct marketing purposes (including profiling related to such direct marketing). More specifically, you wish that:



□ Luceda erases all your personal data from its filing systems. Luceda will contact you again in the future if access is regained to your personal data from a third party

□ Luceda does not process your personal data anymore for direct marketing purposes and ensures that you will never receive direct marketing again from Luceda or its partners

# III. REACTION OF LUCEDA TO YOUR REQUEST

Luceda shall provide without undue delay and in any event within one month of receipt of your request, information on action taken on your request.

Depending on the complexity of your request and the number of requests, that period may be extended by two further months where necessary. In that case, Luceda will inform you within one month of receipt of your request.

If Luceda does not take action on your request, Luceda will inform you within one month of receipt of your request and, in addition, Luceda will provide the reasons for not taking action on your request. Luceda will also inform you on the options to (i) lodge a complaint with a supervisory authority or (ii) seek a judicial remedy.

# IV. PROOF OF YOUR IDENTITY

If Luceda has reasonable doubts concerning your identity, Luceda may request the provision of additional information necessary to confirm your identity.
